Zimbabwe Funds Transfers

Thanks to the loving generosity of OH3 donors, we were able to meet all requests for mealie-meal and oil thru November and all but 2 in December (see **Funds Transfer** list below). Due to depletion of available funds, we were only able to send funds for mealie-meal but not cooking oil to Brother Silence, and as of 24 December, we have not been able to fund any of Brother Mahburi's nor Brother Chinyenze's requests (see reports below). Please know that OH3 operates on a "Lord will provide" basis and does not maintain a management reserve. We seek to fulfill funding requests as soon as possible after being received; and when we have multiple unfilled requests, we fulfill the requests with the oldest "Last Sent" date first. As you will see in our financial report, OH3 is not well-positioned for January. However, we expect our Lord will provide.

Depending upon family size and circumstances, OH3 typically provides a small family 20 kilograms (2.2# per kg) of Mealie-meal and 2 liters of oil (1 liter = 1 qt roughly) for 1 month. Sometimes these amounts are doubled when requested and funds are available, but never for back-to-back 2-month requests. A summary of the cash transfers made since the last newsletter is shown on the next page:

OH3 Cash Flow Summary (1 Oct 2022- 28 Dec 2022)

Here is a summary of OH3 financials since the last newsletter:

OH3 began this reporting cycle with \$479.26 cash. Generous donors contributed \$25062.90 to OH3, and other income came from bank interest. Over \$24,000 went to Zimbabwe starving saints in this calendar quarter. OH3 ended this reporting period with \$516.85 total cash on hand. OH3 donors have always been super generous. One brother sent a special donation in memory of his beloved wife, Myrna J. Warren who passed away on October 30th of this year. It is so uplifting to see the continual compassion and generosity of the Lord's people!

As we have said before, government rules intended to fight fraud and illegal money laundering by criminal groups can make it difficult for charities to transmit funds to Zimbabwe. Government rules force financial services to close users' accounts when secret thresholds are breached--even when transfers less than \$3000 are involved. OH3's risk management approach for dispersing funds helps us be compliant and get funds quickly and safely to our needy brethren. A copy of OH3's risk assessment using the US Department of Treasury's risk mitigation recommendations is included at the end of this report FYI.

Lastly, we are planning to have OH3 Donation Acknowledgements for IRS purposes mailed to all donors by mid to late January. If you do not get yours by 31 January, or the acknowledged amount is incorrect, please let us know. As always, if you have any questions about our financials or suggestions on how we can reduce expenses, please feel free to give us a call.

LOCATIONS HELPED WITH FOOD

CHIPENDEKE2 CHURCH OF CHRIST—JACK CHIDZA

Chipendeke2 is a small group of 26 families with 51 members. Chipendeke 2 is about 8 km from Chipendeke where brother Robert Chinyenze works. This group is called Chipendeke 2 because it is where a school, and clinic is. Since the last newsletter, Brother Chidza has made 3 food requests. Typically, \$660 is needed for both mealie meal and cooking oil for the 26 families at Chipendeke2. **To date all requests have been met.** An email and latest pictures from Brother Jack are provided below:

MASVINGO DISTRICT CHURCHES OF CHRIST—SILENCE CHIRAMBA
(Masvingo 45, Mushandike 60, Maithwa 65, Manica 15)

Since our last newsletter Brother Silence has made 2 food requests. **Due to a shortage of funds OH3 in December, OH3 sent \$1890 of the requested \$2890.** Typically, brother Silence requests \$2870 for the 15 families in Manica, 45 families in Masvingo, 60 families in Mushandike and 15 families at Manica. On the part of churches here, as you may know, Zimbabwe has been going through tough times economically making life very difficult especially for the rural population. This has been coupled with recent droughts. Most people are hungry and assistance with food relief is greatly appreciated monthly. BETERA CHURCH OF CHRIST—MOSES MUKWADA

Since our last newsletter Brother Moses has made 2 food requests. Lately, \$1580 has been requested for 30 kg of mealie meal and no cooking oil for the 78 families at Betera. **To date all requests have been met.** Latest picture from brother Moses is provided below:

There is great need for food especially this time when we are approaching towards the end of the last months to the next season. Brethren at Betera Church demands our hearts love at the moment now. MASHONALAND AREA CHURCH OF CHRIST—FARAI CHINGONDI
(Mahusekwa 56, Mutoko 18, Nyamakate 32)

Since our last newsletter Brother Farai has made 1 food request, and it was met. Typically, \$2070 is requested for the 105 families in his region. Although Brother Farai's health is not all that good, he is active in the Lord's service. Please remember Brother Farai in your prayers. Latest email and pictures are provided below:

3 Dec 2022

Here is my work Report for the month of November 2022. We had 7 restorations from two of the congregations I work with and 3 baptisms. I did spend many days in Hospital in November. I am not responding well to different types of combinations the doctors are trying. I have resorted to use a combination of Hospital drugs and Traditional Herbs and also Chinese herbs. Traditional Herbs lowers blood pressure just for a short time and it shoots up. As for the irregular heartbeat it is improving. I am still having feet swelling and numbness on my right-hand side. My family is doing fine. We are now in our rain season a lot do not have seed and fertilizer. In some areas they no longer need seed as the season running away.





22 MILES CHURCH OF CHRIST—PAIDEMOYO GUTUKUNUHWA (New)

Since our last newsletter, Brothers Paidemoyo, Takudzwa, and Jack have pleaded for food for a small congregation called 22 Miles. This group is situated about 22 miles from Mutare town and is made up of 35 families. These men rotate as preachers there, and they have agreed to have Brother Paidemoyo take ownership for requesting and delivering food to that group. Since our last newsletter, 2 food requests were received for 22 Miles. **All requests have been met.** Typically, \$660 is needed for both mealie meal and cooking oil for 35 families. Latest pictures from Brother Paidemoyo are below:

1 Nov 2022

Hello brother Bill. , I would like to ask for food relief for 22 miles congregation. This congregation is mostly affected by hunger as the other congregations It is situated about 22 miles from Mutare town. You can ask brother Takudzwa Robert Chinyenze, and Brother Jack Chidza they can confirm the situation on the ground. The congregation has 35 families. Your consideration of this congregation is of great importance in him brotherly Paidemoyo.





MUPFURE AREA CHURCH OF CHRIST—MUSONZA MUTANDWA (New)
(Mupfure 35 Chirenje 50)

Since our last newsletter, OH3 vetted another preacher, Musonza Mutandwa and the congregations he serves. One food request has been received, and. **to date all requests have been met.** Typically, \$1110 is needed for 10 kg mealie meal and 2 liters cooking oil for the 85 families. Latest pictures from Brother Musonza are provided below:

Brethren in Christ

I do hereby request for food assistance help for the saints I am working with here. The congregation I am working with 50 families for Chirenje and 35 families for Mupfure. MAHUSEKWA TOWNSHIP CHURCHES OF CHRIST—WILESI RAPHAEL (New)
(Nyahynzi & Tabhanga 59 total)

Since our last newsletter, OH3 vetted another preacher, Wilsei Raphael and the congregations he serves. One food request has been received, and. **to date all requests have been met.** Typically, \$940 is needed for 20 kg mealie meal and 2 liters cooking oil for the 59 families. Latest pictures from Brother Wilsei are provided below:

19 Oct 2022

Thank you so much for your love. Brother Fanuel Bobo has been preaching here in Mahusekwa for a very long time, over 15 years now. Brother Takawora Eliot has been preaching since 2013. Nyahunzvi and Tabhanga churches are in some villages close to Mahusekwa township, which is 40 away from Marondera. It is in Mashonaland East Province, Mahusekwa. These churches were established in 1014 and 2015 respectively. I helped plant these churches, working with brother Wilson Magaya. I will buy the food and distribution with the help of these two preachers and the leading men in the churches they work with. I will send the pictures after the distribution. Brotherly, Wilesi





How OH3 Operates

To give you some insight into OH3 operations, we want to reiterate that none of your donations are used to compensate anyone on the OH3 staff who are all volunteers. The OH3 focus is on emergency food support for saints in Zimbabwe although we sometimes get requests for medical assistance or other support. OH3 occasionally refers these requests, without endorsement or solicitation, to others who might want to meet those non-food related needs; When our help is requested by a donor, we can facilitate the transfer of funds on the donor's behalf as "Donor Directed Support". Otherwise, our focus is on food aid, one month at a time.

OH3 only accepts donations from generous, compassionate individuals like yourselves. We do not accept funds from the Lord's treasury. OH3 outlays fall into 3 major categories: (1) cash transfers for food purchases and distribution, self-sustainment efforts, and donor directed support, (2) wire and PayPal fees, and (3) bank and legal compliance administrative expenses. OH3 operates on a month-to-month basis and strives to minimize retained funds. Funds are sent to vetted Zimbabwe preachers who purchase the food and make distribution to the saints. At the time funds are sent, the receiving preacher and at least one other local man are notified for transparency. After distribution, vetted preachers supply OH3 with purchase receipts and pictures of the families that were helped. (Some of the pictures received are included in this newsletter.) If receipts/pictures are not forthcoming, the vetted preacher is dropped from the list until compliance is achieved. OH3 's Anti-Fraud Risk Assessment

The next page shows how OH3 uses the US Treasury Department's recommended guidelines for avoiding fraud in dispersing funds overseas. The colored boxes reflect OH3's self-assessment, and the numbers for each level of risk were added by OH3 to help calculate an overall risk level. OH3's overall calculated risk level using this tool is 1.36, i.e., slightly above Low Risk. This item is shown in this report for your information. Ways of donating

OH3 prefers donations via a paper check or a “**regular**” bank transfer via PayPal. PayPal does not deduct a fee for a “regular” transfer to OH3 made **using a bank account** whereas they do deduct a fee for an “instant” transfer or where a credit card is used for payment. (PayPal requires your bank routing number and checking account number--located on the bottom of your checks--to sign up for bank transfers.) Signup is accomplished through your personal PayPal account menu. If you need help with PayPal, email OH3 with your phone number and a good time to call; and we’ll call you and help talk you through the setup process. (This quarter, PayPal deducted \$134.77. from your donations in fees). But, with all that said, if you are not comfortable setting up a bank transfer with PayPal, please know that OH3 gives donors credit for their full donation for tax purposes whether PayPal charges a fee or not.
